Mr. Franklin made a motion to deny under authority of R.S. 46:1809 B(1) (not a compensable expense). Ms. Hebert seconded the motion and the motion passed unanimously.

V. ITEMS FOR FULL DISCUSSION

L 12. Richland 16-001

Mr. Guillory made a motion to award \$6,236.04 for SUPPORT. Mr. Franklin seconded the motion and the motion passed unanimously.

VI. LATE ADDITIONS

L 13. St. Charles 16-012

Mr. Franklin made a motion to approve the eligibility of this claimant. Ms. Thibodeaux seconded the motion and the motion passed unanimously.

VII. OTHER BUSINESS

(Updated)

The Board discussed cases of sexual assault involving minors where there is no documentation that these cases were reported to law enforcement. The Board decided to defer those cases until such documentation is received. Ms. Thibodeaux made a motion to approve the above policy. Mr. Frankllin seconded the motion and the motion passed unanimously.

The Board discussed the request from the attorney for the L. Jackson case. It involves a request that the Board waive its right under R.S. 46:1611 to reimbursement from a settlement between Mr. Jackson and S.G.H., Inc. d/b/a Sportsman Super Stop. Ms. Tonkovich made a motion to approve the request of Mr. Jackson's attorney and to waive any right of reimbursement from Mr. Jackson. The motion also authorized Mr. Jeddie Smith to execute any documents or filings in furtherance of its action and to obtain dismissal of the Board from the Petition for Concursus filed by Mr. Jackson. Mr. Guillory seconded the motion and the motion passed unanimously.

The Board decided to skip the May meeting due to lack of funding and hold the June meeting at its normally scheduled date and time of June 14, 2016.

Mr. Franklin made a motion to adjourn the meeting. Ms. Thibodeaux seconded the motion. Ms. Rodi adjourned the meeting at 11:15 a.m.
