The Board discussed the possibility of adding Lost Wages and other payments/reimbursements related to Sexual Assault Crimes to the allowable expenses coming out of the Sexual Assault fund. They also discussed the possibility of requesting that Domestic Violence expenses be added to claims that could be paid from unclaimed gaming funds.

The Board also discussed reducing the felony history denial from FIVE years before and after the crime until THREE years before and after the crime. Ms. Stapleton made a motion to approve the change and make it effective, if possible, for crimes that happen on or after August 1, 2018.
