Ms. Williams made a motion to defer ruling awaiting more information from law enforcement (supplemental police report). Ms. Rodi seconded the motion and the motion passed unanimously.

L 8. St. Tammany 14-004

Ms. Williams made a motion to award \$456.40 for MENTAL HEALTH. Ms. Adcock seconded the motion and the motion passed unanimously. The board also agreed to request an Updated Mental Health Treatment Plan as of 06/16/14.

L 9. Vernon 13-001

Ms. Adcock made a motion to deny under authority of LAC22:8.301(A)(1)(a)(iii) (victim contribution) and under authority of R.S. 46:1809 (B)(3)(b) (failed or refused cooperation). Mr. DiBenedetto seconded the motion and the motion passed unanimously.

L 10. Calcasieu 12-078

Ms. Adcock made a motion to deny under authority of R.S. 46:1809 B(1) (not a compensable expense) because the claimant is ineligible. Mr. DiBenedetto seconded the motion and the motion passed 7 to 0 with 1 abstention.

VII. OTHER BUSINESS

The Board reviewed a policy that was previously decided upon for mental health claims and agreed to make the policy for all claims as follows: All invoices must be submitted to the Board for review within one year of the date of service.
